
## ✨ Duplicate Coverage Request Check

We've implemented a check to prevent duplicate coverage requests from being sent to AIP. This feature includes both offline and online binding processes, and aids producers, agents, and agent reviewers during request submissions or reviews. It ensures that only unique requests are submitted, minimizing accidental duplications. The check applies to various components within a coverage request, excluding tags, and prompts users for confirmation in case of detected duplicates.

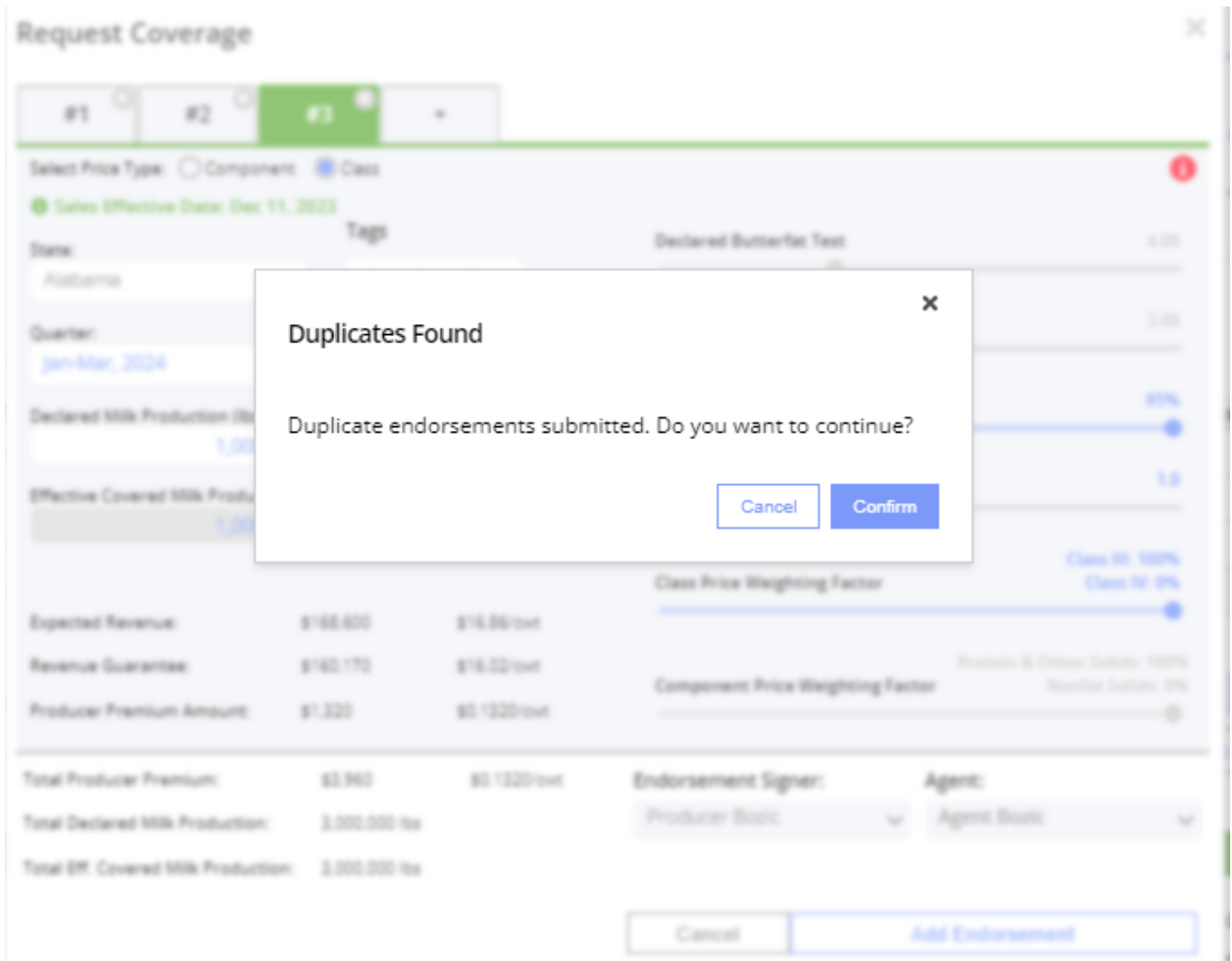
The feature includes two checks: one verifies the existence of an identical active coverage request among all active requests, excluding those in the Canceled status, while the other checks for identical endorsements within the current coverage request being submitted.

If 1st check finds duplicates:

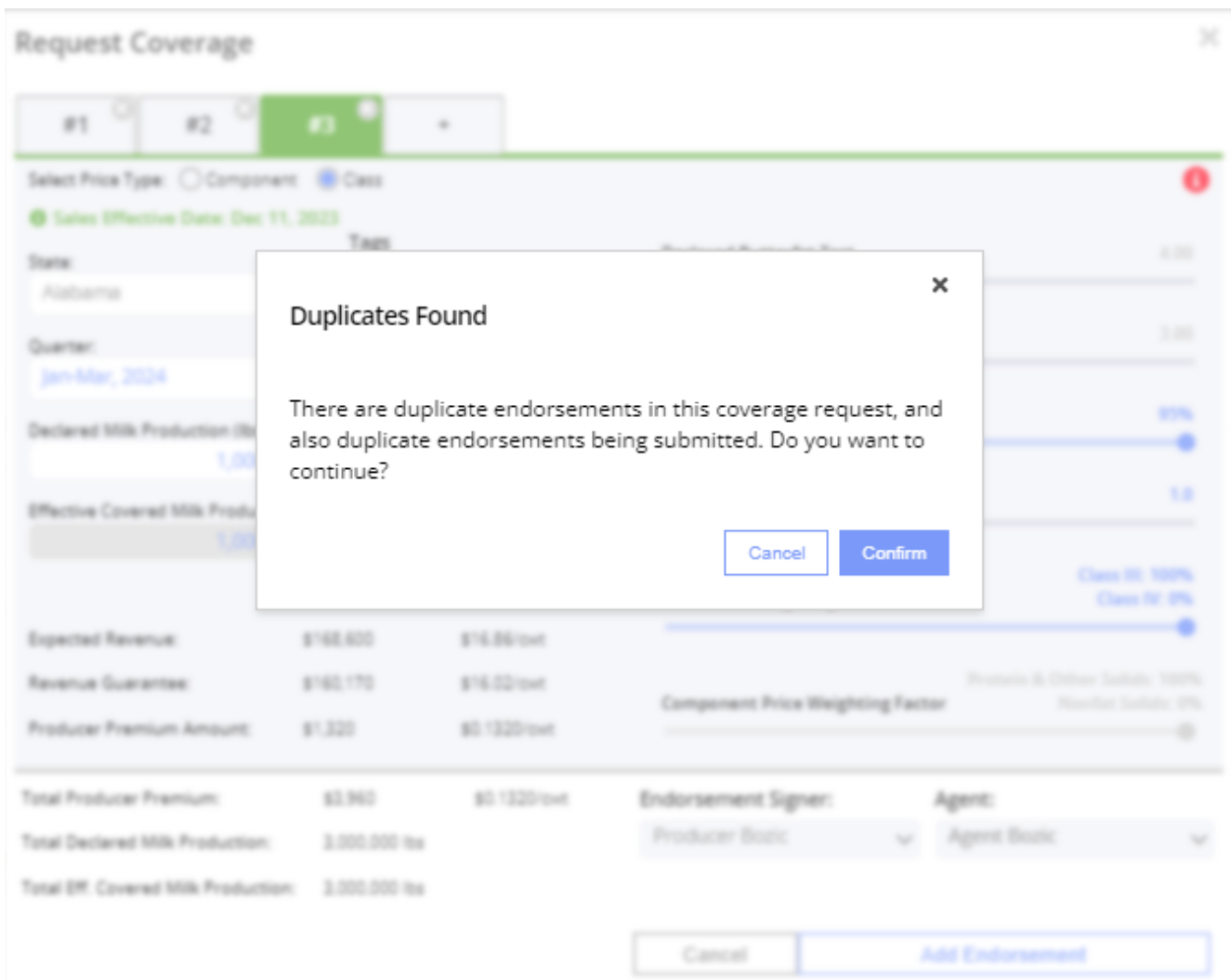





## ✦ Agency Licences

We've added an 'Agency Licences' menu in the Admin Panel for Admin Agents and Global Admins. It allows users to manage one license per state, enabling them to add, edit, and delete licenses. The system prioritizes state-specific license information and defaults to the first listed license when needed. If no licenses are listed, no information will be displayed. This update empowers Admin Agents to efficiently manage state-based licensing information.

## ✨ Enhanced Display of Operation Eligibility in Admin Panel

We've enhanced the Admin Panel to display operation eligibility information, independent of the logged-in user. This update ensures that operation eligibility details are universally displayed in the Admin panel, maintaining consistent icon colors and an identical display for all logged-in users, regardless of their assigned roles.

### 🔧 Improvements

- 🐛 Fixed the issue where, upon accessing the Admin Panel and navigating to 'Insurance Agents', clicking the '+' sign to create a new agent incorrectly displayed 'Delete Insurance Agent' instead of the intended 'Add Insurance Agent'. [@marin.ladovic](#)
- 🐛 Fixed the issue where a network error occurred while saving preferences in 'My Account' due to incorrect number input, ensuring that if any of the SMS toggles are selected, the number must exist and be in the correct format. Additionally, if none of the SMS toggles are activated, the number can either be empty or, if entered, it still must be in the correct format. - 🐛 Fixed the issue related to email notifications for ended endorsements by improving the display adaptability, ensuring optimized viewing across diverse screen resolutions.
